Local Authority Parking Finances in Scotland

This note covers parking finances for the 32 local authorities in Scotland. As in England, local authorities are required to submit details of their finances to the Scottish Government in a standard format. They are normally published in February/March, nearly a year after the financial year end. This report looks at the section on parking income and expenditure for the periods 2014/15.

The published data are less comprehensive than in England and do not split on- and off-street parking or show penalty income separately.

1. Introduction

Of the 32 local authorities, 15 had decriminalised parking (DPE) during 2014/15 including Argyll and Bute which started in May 2014 (although they had been managing their own car parks for many years) and Inverclyde in October 2014. Of the remaining 17 at least five are considering changing but for most small authorities with only one or two towns and no serious parking problems it is not worthwhile making the change.

In February 2014 Police Scotland withdraw the police-controlled traffic warden service. They agreed to retain the wardens in Midlothian, East Lothian, West Lothian, Scottish Borders, Highland, Western Isles, Orkney Isles, Stirling and Falkirk for a limited period beyond February 2014 but this has now ceased and the police are now only dealing with dangerous parking (e.g. on pedestrian crossings) by local arrangement.

Transport Scotland does not publish statistics on the number of parking fines issued although local authorities are supposed to report the number of civil offences to the Scottish Government. Some information is available from council websites including freedom of information requests.

The main cities issue about 370,000 tickets a year, a number which has been falling over the years.¹ The total number in Scotland is likely to be around 450,000, compared with 3.8 million in London and 4.4 million in the rest of England.

The Scottish Parking Appeals Service does not have a website – information about how to appeal is provided on the Citizens' Advice Scotland website.

Two authorities - East Lothian and North Lanarkshire – show no income or expenditure. North Lanarkshire has DPE but has delegated the financial management to South Lanarkshire. In 2013 they estimated this would cost them around £25k per year.

In 2014/15, 16 showed surpluses, 13 showed deficits, one (Shetland) broke even and as noted two do not have any parking accounts. Five councils do not show any income.

2. Summary

3. Income

Total income in 2014/15 was £75.4m, 3% higher than 2013/14 (Table 2). Note that this includes meter and penalty income for on- and off-street parking, but does not include income received by commercial parking facilities.

Edinburgh, Glasgow and Aberdeen account for 70% of parking income (down from 71% in 2013/14). Although the cities only represent 24% of Scotland's population these proportions are likely to be a reflection of the volume of commuters and visitors the cities attract.

4. Costs

Table 3 ranks councils in terms of expenditure on parking.

Overall expenditure remained flat with the three largest established parking authorities showing decreases of 2-12%. Judging by the figures, some of the other authorities, such as Inverclyde, Argyll and Bute and East Dunbartonshire appear to have been ramping up their enforcement as they switch to DPE with a consequent large increase in costs but Fife, East Ayrshire and North Ayrshire have all also increased their costs significantly this year.

The table also shows the proportion of income taken up by costs. Across Scotland it is 52% having fallen from 54% last year. Edinburgh's costs are 33% of income compared with 38% last year. Most of the mid-sized councils spend 75-90% of their income on parking management including enforcement.

5. Surpluses

Table 4 shows the parking surpluses for the past four years and the year on year change. It also shows the proportion that parking surpluses represent of total transport expenditure (before deduction of parking surpluses/deficits).

Total parking *surpluses* amounted to £38.3m between 17 local authorities, of which Edinburgh, Glasgow and Aberdeen contribute 87%. The increase in surpluses over 2014/15 was 8%. The total of parking *deficits* is £2.1m (£1.6m in 2013/14) between 13 local authorities. Overall, parking contributed £36.3m to local authority finances in Scotland in 2014/15 compared with £33.6m in 2013/14 – an increase of 7.9%.

Edinburgh increased its income by £1.2m, decreased its costs by £0.9m and its surplus by £2.1 m. Glasgow increased its income by £0.2m decreased its costs by £0.9m and increased its surplus by £1.0m.

Edinburgh's parking surplus of £17.4m provides 60% of Edinburgh's total transport expenditure while Glasgow's surplus covers 40% and Aberdeen's 30% (Table 5a). For the rest of Scotland, outside Edinburgh, Glasgow and Aberdeen, parking surpluses of £2.9m provide less than 1% of total transport expenditure (Table 5b).


