# Local Authority Parking Finances in England 2022-23

## 1 Introduction

This report uses the DLUHC (formerly DCLG and MHCLG) tables on parking income and expenditure for the period from 2018-19 to 2022-23 (UK Government (2023a)). All councils are required to report their financial information to government, in a consistent format, although there may be some differences in interpretation of what that format is and what it covers. Earlier, councils also submitted budgets for the 2023-24 financial year but on a less detailed basis (UK Government (2023b)). These figures are included where appropriate. The figures have to be on an as-received cash basis without any provision for bad debts or any allowance for capital charges (interest or deprecation).<sup>1</sup>

This report covers 311 local authorities in England but excludes the national parks which declare parking income.

The income and cost headings used in this analysis are:

- 1. On-street income, expenditure
- 2. Off-street income, expenditure
- 3. Total transport income, expenditure

The accuracy of this analysis depends on the accuracy with which local authorities complete the annual financial returns they make to central government and upon which this assessment is based. These headings do not always agree with accounts published by local authorities because of their different treatment of overheads and allocation of surpluses to other transport projects. In particular, the data around the COVID pandemic have led to significantly fluctuations in parking income and expenditure and this leads to some of the figures for year-to-year changes appearing quite extreme. Consequently readers of the report are asked to rely on their own judgement regarding the usefulness of the data presented here.


Total income from parking in 2022-23 in England was £1.84 billion, 6.2% higher than in 2021-22. On-street income rose by 9.5% and off-street income by 0.9%. Expenditure rose by 3.1% for on-street and by 5.9% for off-street parking. As a result, the combined surplus from both on- and off-street parking was £923 million, 8.1% higher than the previous financial year and 2.1% higher than four years ago.

Local authorities fell short of their 2022-23 budgeted surplus of £995 million by 7.2%. Their budgeted surplus for this next financial year (2023-24) is £1021 million, 10.6% higher than the actual for 2022-23. If the 2023-24 budget falls short by the same proportion as the 2022-23 outcome, then total parking surpluses would amount to £948 million.

The on-street parking surpluses must, by law, be used for transport projects. Overall, local transport net expenditure in 2022-23 fell to £4.8 billion. Without the contribution from parking surpluses, net expenditure would have been 19.3% lower.

Table 3 provides a comparison between London, England excluding London, Wales, and Scotland for the most recent available data, while Table 4 compares the changes between 2022-23 and the previous year, with the average annual change over the four-year period starting in 2018-19 (or the most recent four-year period for which data is available). In the last year the surpluses for London have increased by 5.4%, which is more than the average annual increase observed over the preceding four years, which was 4.2%. For the rest of England excluding London the surpluses have increased by 12.0%, which is more than the four-year average annual decrease at 3.7%.

On average, parking surpluses in Great Britain have risen by about 188.3% annually over the four years for which data are available compared with 2.7% annually for the Retail Prices Index during the same period (Office for National Statistics (2024)).<sup>2</sup>

## 3 Income

Parking income is derived from three main sources: meter income (including ticket machines and apps), residents' and business permits, and penalties. Other sources are towing and storage charges although relatively few councils operate pounds now. Total income in 2022-23 was £1,841 million, 6.2% higher than in 2021-22. In London boroughs the total income was £881 million, 6.8% more than in the previous year, while the total for the rest of England was £960 million, 5.6% more than in the previous year.

Table 5 shows the incomes for all the London boroughs for the previous 5 years, their most recent annual change and the average annual change in income over the preceding 5 years. Table 6 has the same information for the top 20 councils outside of London. For a full table of all the local authorities in London see Table 13 in the Appendix.

In England as a whole 251 councils increased their income over the past year and 38 decreased their income. Another 14 councils' incomes stayed the same. There are 35 councils that did not report income data in this or the previous fiscal year, so we cannot define the change.

The top three English councils by income were Westminster, Kensington & Chelsea, and Hammersmith & Fulham, and between them accounted for 11.5% of parking income.

The three councils which had the largest year-on-year percentage increases in income were Pendle (up 750.0%), Norfolk (up 458.6%) and Sandwell (up 288.7%). The biggest decreases were in Leicestershire (28.1%), and Knowsley (24.6%) (excluding Bassetlaw, and Cherwell where income was under £30,000).

# 4 Expenditure

Overall expenditure on parking rose to £918 million, up 4.3% from 2021-22 for both onstreet and off-street. Expenditure in London went up by 9.2% and up by 1.6% in the rest of England. Expenditure represents 44.4% of income for on-street parking and 59.5% for off-street.

Table 7 ranks the London boroughs in terms of expenditure on parking while Table 8 lists the top 20 English councils outside London. See Table 14 in the Appendix for a comprehensive list of all 353 local authorities in England.

Overall expenditure has risen by £38 million (4.3%) after a rise of £63 million last year.

In England as a whole 225 councils increased their expenditures over the past year and 70 decreased them. Another eight councils' expenditures stayed the same. There are 35 councils that did not report expenditure data in this or the previous fiscal year, so we cannot define the change.

The top three English councils by expenditure were Westminster, Lambeth, and Hammersmith & Fulham, and between them accounted for 8.3% of parking expenditure in the country.

The largest increase in expenditure in England occured in Newham where it increased by 671.3% while Mansfield and Barnet increased by 85.9% and 59.0% respectively. The biggest decreases were in Bassetlaw (144.6%), and Norfolk (59.4%) (excluding Cherwell

# 5 Surpluses

In total, councils in England made a surplus of £923 million in 2022-23, 8.1% higher than in 2021-22. Of this total, £536 million (58.1%) came from London and £387 million from the rest of England. This excludes a £0.0 million surplus from parking in National Parks. Money from any workplace parking levy schemes is excluded from the analysis for the sake of clear comparison between local authorities. It is currently unique to Nottingham.

The total *surpluses* for London amounted to £536.0 million between 33 authorities, of which the top three–Westminster, Kensington & Chelsea, and Hammersmith & Fulham– accounted for 27.5%.

No London councils made a loss last year (see Table 11).

Overall, parking contributed £536.0 million to local authority finances in London in 2022-23 compared with £508.6 million in 2022-23, an increase of 5.4%.

Bromley increased their surplus by 84.0% while Havering and Newham increased by 62.7% and 61.1% respectively. The biggest decreases were in Croydon (33.7%), and Sutton (25.0%).

None of the London boroughs has had a deficit two years in a row.

The total surplus from parking outside London of £387 million in 2022-23 was 12.0% higher than in 2021-22. Brighton & Hove was the highest earning council outside London, ranking as the fourth largest nationally, and with a surplus in 2022-23 of £30.1 million, 1.1% higher than in 2021-22. Table 12 lists the top 20 councils outside of London. The full table for all English councils is available in the Appendix as Table 16.

The total *surpluses* outside London amounted to £935.1 million between 228 authorities, of which the top three–Brighton & Hove, Nottingham, and Bournemouth Christchurch & Poole–accounted for 14.6%. 50 councils made a loss with the total of parking deficits falling to £11.9 million from £14.6 million last year.

Oadby & Wigston increased their surplus by 30300.0% while Warrington and Newcastleunder-Lyme increased by 2076.0% and 1735.7% respectively. The biggest decreases were in Ashford (60.8%), and Coventry (58.7%) (excluding Tandridge, and Wyre with a surplus under £30,000).

Essex increased their deficits by 641.2% while Leicestershire and Spelthorne increased by 245.9% and 189.2% respectively The biggest decreases were in Hampshire (53.9%), and St Helens (45.2%) (excluding Broadland, West Lindsey, South Ribble, North Northamptonshire, and Stoke-on-Trent with a deficit under £30,000)
